Technology and innovation were addressed in *Prof. Pradeep Kumar's* PhyGital Healthcare, *Professors Charu and Manali's* AI and IoT in smart healthcare, and *Mr. Nirmalendu Jena's* digital transformation in healthcare, showcasing real-world applications to improve patient care and operational efficiency.

Participants also developed personal growth and resilience through *Dr. Teena Bharti* and *Dr. Namita's* mindfulness and emotional intelligence, and *Ms. Pragya Mishra's* yoga and meditation sessions. Legal and ethical dimensions were covered in *Mr. Gaurav's* medicolegal issues session, preparing doctors for compliance and risk management.
