### Overall results will be divided into following four types:

Type I: Provisional Admission Offer: Candidates will receive the confirmed offer and will be asked to deposit EoI Fee and Acceptance Fee.

Type II: Waitlist EoI: Candidates will be in wait-list after depositing EoI Fee, and offers will be made on the basis of vacant seats available.

Type III: Cleared sectional Cut-off, but not in Waitlist EoI as on date: Candidates will be considered for Waitlist EoI in the later stage if required.

Type IV: Not cleared the sectional cut-off, will not be considered.

Offers for further SNG will be sent in the next list, based on the number of girls in the main pool.

# Students (Type I) will be asked to confirm the WL EoI by depositing INR 15,000 in IIM Bodh Gaya account (through SBI collect) till 25<sup>th</sup> July 2024. Further they will be asked to deposit remaining amount.

# Students (Type II) will be asked to confirm the WL EoI by depositing INR 15,000 in IIM Bodh Gaya account (through SBI collect) till 25<sup>th</sup> July 2024. The WL number will be shared with them on 27<sup>th</sup> July 2024.

##The Provisional Admission Offer (students of Type I) will be shared on the basis of the vacant seats.

For the remaining candidates (Type III) the EoI will be decided in the next list, if required.

Based on the Indian GENERAL category students' cut-off scores, a shortlist of international applicants would be created and they would be subsequently interviewed.

**Candidates are advised to verify the fulfilment of the following eligibility criteria for admission into the IPM 2024-29 batch.**

**Qualifying Exam:** Candidates should have passed 10+2/XII/HSC examination in arts/commerce/science stream or equivalent with 60% (55% for candidates from SC/ST/PwD/Transgender) or more in the year 2023 or appearing in 2024. Candidates who are likely to complete standard XII/ HSC or equivalent by 31 July 2024 can also apply. The candidate must have passed the class 10th examination with 60% (55% for candidates from SC/ST/PwD/Transgender) or more in the year not before 2021.

The percentage of marks obtained by the candidate in Class X and Class XII would be calculated based on the Board's regulation. If there is no such regulation regarding aggregate marks from the concerned board, then the aggregate marks of all the subjects that appear in the grade sheet should be considered for calculating the passing percentage.

The application of the candidates, who are appearing in Class XII examination, will be provisional till their Class XII result. The candidates who do not score the requisite score as above will be considered to be out of the application/admission process. Admission to the programme is open to Indian citizens only. Further details (about the course starting date, withdrawal policy, etc.) will be available soon.
